# **Recreation Committee**

# **Library Report**

President Senken presented the library report on behalf of Randy Colahan who could not be present. Stewart Manor voted to join the Garden City Library system. This will lead to an increase in revenue for the GC Library. The next Board meeting is April 14<sup>th</sup>.

### **School Board**

President Senken presented the School Board report on behalf of Laura Hastings, who could not be present. 126 students opted out of the State wide tests. May 13<sup>th</sup> is the public budget hearing and May 20<sup>th</sup> is the School Budget vote.

#### **Traffic Commission**

President Senken presented the report. A Village resident has requested that a stop sign by added at the corner of Kensington Road and Salisbury Road, in light of the recent death of a jogger who was struck by a car. Trustee DeMaro stated that he planned to speak to Police Commissioner Jackson about the possibility of stationing a police officer at the intersection to monitor traffic. Some residents at the meeting suggested a traffic light at the intersection. Residents were encouraged to contact Adelphi President, Robert Scott, to ask him to address the student base regarding driving safety around the Village.

President Senken then introduced a guest Speaker, Laura Schaefer, the newly elected County Legislator whose district includes Garden City. She gave a brief background and said she was excited to be representing Garden City. She welcomed residents to contact her office if they had any questions or if she could be of assistance.

# **Trustee's Report**

Trustees discussed the sale of a Village owned parking lot on Cherry Valley Avenue to the Town of Hempstead. The Village continues to negotiate with the various employee unions. The Trustees also gave an update regarding the ACORN litigation, stating that the case is in the remedies phase.

During the resident question portion of the meeting, a resident questioned the lack of curbs on Meadbrook Road. Another resident stated that the play area around the tennis bubble was very messy. Kristina Russo stated that she will look into it and make sure it gets cleaned up.
