2 (Following recitation of the Pledge of  
3 Allegiance, the meeting was called to order.)

4 MAYOR MCGINTY: Sergeant Dunnell,  
5 would you be kind enough to give your  
6 police report.

7 SERGEANT DUNNELL: Good evening,  
8 everyone. We have good news and bad  
9 news as far as activity was a little  
10 low as far as moving violations and  
11 parking violations for the month. We  
12 had four moving violations, 38 parking  
13 violations issued. We did have three  
14 arrests. I believe they were all  
15 narcotics arrests mainly originating  
16 out of the train station which was  
17 good. As far as burglaries and  
18 robberies and any other major cases  
19 involving we had none. I guess last  
20 week or it was a few weeks ago there  
21 was an incident down at Pops with  
22 focusing on noise violation. Now that  
23 the summer is over it should be  
24 dissipating. As far as I know, no  
25 other major incidents.

2 Does anybody have any questions  
3 here from the Board? Do you have any  
4 questions about police activity, focus,  
5 any issues, concerns, traffic? I know  
6 obviously with the Barnum Bridge we  
7 still have some stuff going on but  
8 anything else in the area that I can  
9 accommodate with, any questions at all?

10 MR. ZIMATORE: Roland Zimatore, 185  
11 Suffolk Road. Through the media I hear  
12 people complaining about cars are being  
13 broken into. Is that --

14 SERGEANT DUNNELL: Not here. There  
15 is some in Oceanside but as far as I  
16 know they are either not getting  
17 reported to us.

18 MR. ZIMATORE: Right. That's what  
19 I was wondering, okay.

20 SERGEANT DUNNELL: There was a  
21 little incident on the north end of  
22 Oceanside but again when we tell the  
23 residents all the time as long as you  
24 leave your cars locked the crime  
25 prevention goes to 95 percent. It's

2 mainly kids or younger people just  
3 pulling open car doors, open car doors.  
4 Almost never do they break into a  
5 locked car so lock your cars and  
6 usually it avoids that situation.

7 MAYOR MCGINTY: Sergeant, the  
8 only -- I wasn't here at the last  
9 meeting but I read the transcript over  
10 a number of times. Sergeant, I would  
11 like to set the record straight. I  
12 believe the deputy inspector misspoke  
13 last week and I am going to set the  
14 record straight.

15 SERGEANT DUNNELL: Okay.

16 MAYOR MCGINTY: During the week  
17 there are a minimum of two cars that  
18 patrol the village and the school  
19 district. They are here all of the  
20 time. Does that mean they are not  
21 called on?

22 SERGEANT DUNNELL: Of course not.  
23 They are called to emergencies.

24 MAYOR MCGINTY: On the weekend  
25 there are three cars around here on the

2 two shifts and you know the police  
3 department they have two 12 hour  
4 shifts. They are around. Are they  
5 called away? Yes. Are they performing  
6 their duties here? In the last four  
7 years they have stepped up their game  
8 to use the vernacular. This is the  
9 finest police department bar none.  
10 Their narcotics unit has been -- I  
11 speak to other mayors. You are aware  
12 of this?

13 SERGEANT DUNNELL: Right.

14 MAYOR MCGINTY: They tell me, "You  
15 know, we were having a lot of trouble  
16 with narcotics and arrests." I keep my  
17 mouth shut because I don't want  
18 somebody to get to the 4th Precinct and  
19 say, "Well, you are spending so much  
20 time with McGinty. What about us?" So  
21 I keep quiet but we don't have the  
22 level of complaints other neighbors do.  
23 This is a fine, fine group of men and  
24 women and, Sergeant, I am deeply  
25 appreciative.

2 SERGEANT DUNNELL: Thank you. It  
3 means a lot.

4 MAYOR MCGINTY: Yes, sir.

5 SERGEANT DUNNELL: I know there was  
6 an incident last month whether in  
7 transit you know about response times  
8 to a call for domestic into Island  
9 Park. I am not going to go into  
10 specifics but again it was an  
11 incredibly busy night and in Atlantic  
12 Beach -- you know, I mean Atlantic  
13 Beach cars come over this and that but  
14 as far as response time and like the  
15 Mayor said you can't touch our response  
16 times. We have plenty of Oceanside  
17 cars, plenty of Island Park cars and I  
18 feel as a supervisor I do work nights  
19 and 75 percent of the time that whole  
20 eastern zone their response times are  
21 great and, you know, we want the  
22 public's help. If there is a  
23 complaint, this or that certainly bring  
24 it up. All my guys, all new guys, all  
25 approachable. If you have got a

2 concern, you know, certainly let us  
3 know and then if you are not satisfied  
4 with what the officer has done I am  
5 always around.

6 MAYOR MCGINTY: Sergeant, thank  
7 you.

8 SERGEANT DUNNELL: Thank you again.

9 MAYOR MCGINTY: Questions,  
10 comments? Yes, ma'am.

11 MS. RISOLO: Mildred Risolo. We  
12 had a policewoman here at the last  
13 meeting.

14 MAYOR MCGINTY: That was a deputy  
15 inspector.

16 MS. RISOLO: Is that who you are  
17 speaking of?

18 MAYOR MCGINTY: Yes.

19 MS. RISOLO: She only said one car.

20 MAYOR MCGINTY: Isn't so.

21 MS. RISOLO: Because one car didn't  
22 seem sufficient.

23 MAYOR MCGINTY: Yes, sir.

24 MR. ZIMATORE: What cars are  
25 assigned to Island Park? 421?

2 SERGEANT DUNNELL: 421 is  
3 designated and 420 is kind of his  
4 back-up post so he has that as well.  
5 So it's really 420 and 421 both have  
6 Island Park, North Long Beach, not  
7 really going to the very south end of  
8 Oceanside. So pretty much from the  
9 Barnum Bridge everything down there is  
10 two set cars.

11 MAYOR MCGINTY: Thank you. Yes,  
12 name and address.

13 MS. SCULLY: Roberta Scully, 60  
14 Suffolk Road. There was a lot of stuff  
15 on Facebook -- I know we all look at  
16 Facebook -- last night about gunshots  
17 or firecrackers. Did you hear?

18 SERGEANT DUNNELL: Nothing over  
19 there. No, I worked. There was  
20 absolutely no gunshots.

21 MS. SCULLY: So you don't know.  
22 Did anybody here stand up and say  
23 anything about it because it was all on  
24 Facebook and we were all so worried.

25 TRUSTEE PACCIONE: But that's the

2 problem. The Mayor and I had met with  
3 Inspector Steinberg the other night --

4 MAYOR MCGINTY: And Sergeant  
5 Solomon.

6 TRUSTEE PACCIONE: And Sergeant  
7 Solomon and two of the other officers  
8 and they said the same thing. If  
9 people go on Facebook and constantly  
10 write it on there --

11 MS. SCULLY: Matthew, that's my  
12 point.

13 TRUSTEE PACCIONE: That's what I'm  
14 saying and that's what he's saying  
15 too --

16 MS. SCULLY: The point is --

17 TRUSTEE PACCIONE: -- if you see  
18 something, say something.

19 MS. SCULLY: -- everyone is uptight  
20 about it.

21 TRUSTEE PACCIONE: That seems like  
22 the normal thing.

23 MS. SCULLY: And nobody shows up to  
24 the meetings to ask about it. So I was  
25 just wondering with all of the people.

2 TRUSTEE PACCIONE: We said the last  
3 time too because the last time someone  
4 said the same thing, "Didn't you read  
5 it on Facebook?" No, I don't go on  
6 Facebook. All over those pages with  
7 the BS and nobody is here.

8 MS. SCULLY: Right.

9 TRUSTEE PACCIONE: So you are here.

10 SERGEANT DUNNELL: We try to make  
11 every meeting about --

12 TRUSTEE PACCIONE: But they are not  
13 on Facebook.

14 MS. SCULLY: For me I thought it  
15 sounded like firecrackers. You know,  
16 kids have firecrackers but it was two  
17 nights where it was bop-bop-bop-bop-bop  
18 and then it stopped and then another  
19 night and you know.

20 SERGEANT DUNNELL: There was no  
21 gunshots.

22 MS. SCULLY: When I responded on  
23 Facebook I said, "Well, it sounded like  
24 firecrackers. Did you call 911?" And  
25 everybody doesn't do anything about it

2 so it's frustrating because they stir  
3 the pot and then nobody does anything.

4 SERGEANT DUNNELL: We're familiar  
5 with it.

6 MS. SCULLY: Thanks.

7 SERGEANT DUNNELL: Everybody have a  
8 great night.

9 MAYOR MCGINTY: You have one more?

10 MS. RISOLO: Yes. I wanted an  
11 answer to the front page of the Nassau  
12 Herald a few weeks ago about the drug  
13 epidemic that we are supposed to have.  
14 What is this about? I mean, where is  
15 this? We don't even have a high  
16 school. How can we have such an  
17 epidemic?

18 MAYOR MCGINTY: The entire county,  
19 the entire island it's the heroin, the  
20 opioids, the painkillers. It's --

21 MS. RISOLO: Yeah but we are  
22 supposed to have a gang here. I mean  
23 this is what was said a few weeks ago.

24 SERGEANT DUNNELL: I don't know.  
25 There is no gangs or no gang

2 affiliations here. Could there be a  
3 possible gang, you know what I mean, we  
4 identify the only gangs we have and  
5 know about and hear about are in Long  
6 Beach. As far as even Oceanside, there  
7 is no real gang activity here. The  
8 drug epidemic is just countywide. It's  
9 not specific to here. I have mentioned  
10 unfortunately a lot of the drug  
11 activity comes from the train station.  
12 People are coming off the train, going  
13 off the train. We are aware of it. We  
14 have plainclothes units who work inside  
15 our precinct. We also have special  
16 units who are countywide who just sweep  
17 the area, you know, once a week, once a  
18 month, whatever it is depending on  
19 requests of the Village and stuff.

20 MS. RISOLO: Right.

21 SERGEANT DUNNELL: We sit there.

22 MS. RISOLO: You know, it was front  
23 page news.

24 SERGEANT DUNNELL: I understand.  
25 It's certainly not isolated to Island

2 Park. It's a countywide epidemic.

3 MS. SCULLY: It said on the paper  
4 that Island Park is the highest  
5 incident of heroin arrests in the  
6 county right and that you know that's  
7 really not good.

8 SERGEANT DUNNELL: I can't speak to  
9 that. I don't think that's accurate.  
10 I didn't write it. I don't know where  
11 that number is from but, you know, it's  
12 not like we know Island Park is a high  
13 narcotics area.

14 MS. RISOLO: It has made all of the  
15 people of Island Park uptight.

16 MAYOR MCGINTY: Frankly, I think  
17 perhaps you should speak to the Herald  
18 directly.

19 MS. SCULLY: You know what, Mike?  
20 I think you should speak to the Herald.  
21 You are the mayor and you should call  
22 them up and say what right do they have  
23 doing that to Island Park because  
24 everybody went nuts when they read it.

25 MAYOR MCGINTY: I will be glad to.

2 MS. SCULLY: Good. That coming  
3 from you would be a lot better than  
4 coming from me or Millie.

5 MAYOR MCGINTY: Well, I don't know  
6 about that.

7 MS. SCULLY: I think so.

8 TRUSTEE PACCIONE: People are  
9 getting arrested. They are passing  
10 through. You know, if you get an  
11 arrest on Austin Boulevard and he's  
12 from Long Beach and I see the police  
13 report every morning and it seems that  
14 it's a lot are getting arrested that  
15 are passing on Austin Boulevard and  
16 they live in Long Beach.

17 MS. SCULLY: It said Island Park.

18 TRUSTEE PACCIONE: I read the  
19 article.

20 MS. RISOLO: I mean it's a  
21 disgrace. How do you answer to that?

22 MS. SCULLY: No, it's scary because  
23 everybody is saying, "Oh, Island Park  
24 with all of the drug addicts." You  
25 know drug capital of the world.

2 SERGEANT DUNNELL: In defense of  
3 the Mayor you are asking whether he is  
4 going to ask the Herald. I don't know  
5 and I am being honest I don't -- I  
6 would tell you it's a rash at the train  
7 station or somewhere else. I just  
8 don't believe that that's true. I  
9 don't know where those numbers are.

10 MS. SCULLY: There were a couple of  
11 arrests in Island Park where there were  
12 heroin problems.

13 SERGEANT DUNNELL: That's right and  
14 I understand.

15 MS. SCULLY: That doesn't put  
16 Island Park on the map.

17 SERGEANT DUNNELL: It's  
18 irresponsible of the person who wrote  
19 the article to do it.

20 MS. SCULLY: Exactly.

21 SERGEANT DUNNELL: I would tell you  
22 if a) stay away from the train station  
23 it's a federal thing. I am reporting  
24 on how many arrests we have for the  
25 month of September -- I mean for August

2 we had three narcotics arrests. That's  
3 not anything out of control. It really  
4 isn't.

5 MS. RISOLO: With the sale house I  
6 understand the kids don't even -- the  
7 parents don't even want to let them  
8 come to town.

9 MAYOR MCGINTY: I will discuss that  
10 in a moment.

11 MS. RISOLO: We never had so many  
12 problems.

13 MAYOR MCGINTY: I will discuss that  
14 in a moment.

15 SERGEANT DUNNELL: Again we will be  
16 here every month. If you have any  
17 concerns again the best thing to do is  
18 lock your cars and if you see a problem  
19 always call us. There are plenty of us  
20 around. I have never had a problem  
21 with coverage in this area. I can  
22 always pull more. We have a lot of  
23 Oceanside cars. We have plenty of  
24 attention in this area but you keeping  
25 us informed is a big help. All right.




24 DEPUTY MAYOR ANNARELLA: Deputy  
25 Mayor Joseph Annarella. If I just may

3 for the public that don't know. Those  
4 signal nines those are medical  
5 emergencies that call to the ambulance  
6 and medical technician. That's usually  
7 the biggest number that we have. We  
8 know what that is. I don't know if the  
9 public knew what that was. I just  
10 wanted to clear that up.

11 My report the Public Works report.  
12 The following was collected in August:  
13 There is 268.43 tons of municipal solid  
14 waste, 12.61 tons of mixed glass. All  
15 Village owned property is being  
16 maintained. All street lights and  
17 meters that were reported not working  
18 are being repaired.

19 Tonight the DPW is out doing the  
20 street light check right now. We have  
21 had -- I reported three to them and  
22 they do -- well, every six weeks we go  
23 out. We do it because we usually get  
24 to them before people report them. So  
25 we will take your call any time. If we

2 don't show up, we will get on it the  
3 next day but we try to get ahead of the  
4 curve with that.

5 I had a meeting with the DPW on  
6 Monday. We started looking at our  
7 winter equipment already. We try to be  
8 a season ahead. We are going to take  
9 out the plows, sanders, snowblowers and  
10 decide what sand and salt we need. We  
11 are going to try to get a jump on that,  
12 what parts we need, what has to be  
13 repaired. The John Deere you saw on  
14 the beach this year doing the raking  
15 doing that beautiful job on the beach.  
16 We also do double duty we use it in the  
17 winter time as part of our plowing  
18 fleet now. So every piece of equipment  
19 will be used year round. That's my  
20 report at this time.

21 MAYOR MCGINTY: Deputy Mayor  
22 Trustee, thank you.

23 Good evening. I have got an  
24 extensive report tonight. It's busy.  
25 With regard to the Hazardous Mitigation

3 Commissioner Parrino. As you know  
4 about a month and a half ago he took a  
5 walking tour of the Village with  
6 Councilman D'Esposito, Assemblyman

9 TRUSTEE PACCIONE: The school board  
10 too.

11 MAYOR MCGINTY: The school, right.  
12 The president of the school board was  
13 there also.

14 TRUSTEE PACCIONE: The  
15 superintendent also.

16 MAYOR MCGINTY: Superintendent  
17 Levino too.

18 TRUSTEE PACCIONE: A whole host of  
19 people.

20 MAYOR MCGINTY: We had a party so  
21 to speak. As we speak they are  
22 completing their due diligence that is  
23 the federal side of the HMGP program.  
24 They are completing their due diligence  
25 and the state side DHSES the governor's

2 office has formally requested a  
3 rollover of surplus funds from phase  
4 one into phase two. As you are aware,  
5 we were able to clean all of the drains  
6 and all of the drain boxes within  
7 budget. As a matter of fact, we saved  
8 \$1,140,000 of the budget through it.  
9 We built a containment area at the DPW  
10 garage and that was directly supervised  
11 by the New York State Department of  
12 Environmental Conservation. I know  
13 it's being redone but it's important.  
14 The liquid that we got out of that  
15 containment area we went through three  
16 filtrations a tertiary process and that  
17 water was clean enough to go back into  
18 the drains and it kept our not only  
19 environmentally sound but it kept our  
20 removal costs at a minimum. So those  
21 funds are being rolled into phase two.  
22 We are progressing with the  
23 replacement of fuel tanks at the DPW  
24 garage. Our fuel tanks have aged out.  
25 Under the -- we are using a consulting

2 firm Walden Engineering and they have  
3 ascertained that there is no  
4 environmental difficulties in the  
5 grounds below, which was a real concern  
6 giving the age of the tanks.

7 We also followed -- although we  
8 weren't dictated to -- we also followed  
9 the 30 percent MWBE federal rule. The  
10 rule says that you have got to have a  
11 30 percent on any project a 30 percent  
12 women or minority owned business and  
13 that's if you are getting reimbursed  
14 for federal funds. What we felt as a  
15 Board we felt that it was important for  
16 the feds and the state to know that we  
17 were serious about following their  
18 rules and regulations. So we used a  
19 survey team a minority woman-owned  
20 survey team for the work on -- the  
21 preliminary work on the tanks. In  
22 addition, the Town of Hempstead and the  
23 Village are entering into an  
24 intermunicipal agreement so that we can  
25 utilize Town of Hempstead fuel depot

2 during the construction. One of our  
3 fears if you want to call it that was  
4 that we pay retail for day to day fuel  
5 here in the Village for our trucks. We  
6 didn't want to do that so that's we are  
7 moving ahead with that. It's a core  
8 savings measure.

9 We have made progress with our  
10 resiliency and hardening at the  
11 firehouse. The second floor serves as  
12 our emergency management center. As  
13 recently as today -- excuse me, a  
14 schedule was presented to the  
15 governor's staff as well as to National  
16 Grid on the progress being made and the  
17 work that's being done to rebuild the  
18 second -- I'm sorry -- to perform  
19 resiliency and hardening of the  
20 Village's emergency management  
21 operations. Now the reason National  
22 Grid was told because we have entered  
23 into an agreement for a PILOT project  
24 with National Grid. They are going to  
25 install energy conservation equipment

2 for heating and lighting at the  
3 firehouse at a very minimal cost to the  
4 Village if any and if that's successful  
5 we are going to talk them into  
6 expanding that program. But we have  
7 worked with National Grid towards  
8 providing efficient and effective  
9 energy, reducing the carbon footprint  
10 because we are concerned with the  
11 greening of this Village.

12 With regard to Nassau County the  
13 shared services program we have come to  
14 an agreement with Nassau County for the  
15 operating maintenance of Island  
16 Parkway, Long Beach Road and Warwick  
17 Road. We will be performing the  
18 maintenance and whether it be storm  
19 drains, street sweeping or snow removal  
20 as well as wherever we have green space  
21 if you will along those blocks, and the  
22 county has estimated their savings in  
23 excess of \$100,000 which they will  
24 share with us. Whether they share that  
25 in actual dollars or they share that

2 with us in capital or operating  
3 efforts, we are working on that but the  
4 point is that Nassau County will  
5 continue to maintain the sanitary sewer  
6 system. We will maintain the drain  
7 system. We have the ability to tie  
8 into the drain system on Island Parkway  
9 which will minimize the flooding on  
10 Suffolk, Sherborne, Pershing and  
11 Washington Places.

12 So those are positive and while --  
13 I will forget to mention this. I will  
14 be right there. We are also going to  
15 enter into a intermunicipal agreement  
16 with the Village of Valley Stream. We  
17 find that no matter what we do  
18 municipal signs are expensive and we  
19 cannot afford to make our own signs.  
20 However, the Village of Valley Stream  
21 will do it effectively and budgetary,  
22 fiscally effectively. We are getting a  
23 good deal. I have given them -- I have  
24 presented them with our vouchers for a  
25 .08 gauge aluminum and the signs that

2 we have gotten and the prices. Just by  
3 eliminating shipping and handling we  
4 are going to be way ahead of the game.  
5 So once again we are cutting spending.

6 Yes, ma'am.

7 MS. SCULLY: You mentioned that  
8 Nassau County they would not maintain  
9 Long Beach Road, Island Parkway,  
10 Warwick Road. Those were all county  
11 roads.

12 MAYOR MCGINTY: Those were the  
13 three county roads within the  
14 geographic boundaries of the Village.  
15 We will be maintaining it.

16 MS. SCULLY: Okay. And when you  
17 say maintaining it --

18 MAYOR MCGINTY: Oh, let me stop  
19 you.

20 MS. SCULLY: Well, I didn't ask my  
21 question.

22 MAYOR MCGINTY: I know but I think  
23 I know the question. Let me try.

24 MS. SCULLY: Well, why don't you  
25 let me ask it. Warwick Road is in dire

3 MAYOR MCGINTY: They are paying for  
4 it.

5 MS. SCULLY: And they are doing it?

9 paying for it.

10 MS. SCULLY: Same with Island

21 services is the way we are going to go  
22 in the future. Otherwise per capita  
23 aid is going to be hit hard.

25 Harbor Isle and I am thinking of Barnum

3 Harbor Isle and Barnum Island.

4 MAYOR MCGINTY: Either the county

10 MS. SCULLY: I am a little worried

10 our pothole maintenance and frankly we  
11 can do potholes 24 hours a day. We are

25 the staff of Assembly Ways and Means

3 situation but it's forthcoming.

4 So as we continue we will be moving  
5 into the Bank of America end of  
6 September and after discussions with

9 a passive flood prevention system. The  
10 result of that will be we won't have to  
11 raise the building so there won't be a  
12 move in, move out. We will be within  
13 the guidelines, safely within the  
14 guidelines and frankly it will mean a  
15 future savings of debt service in the  
16 neighborhood of \$65,000 a year. I know  
17 it's a broken record but I will keep  
18 saying it. We continue to cut spending  
19 because we're cognizant of the impact  
20 of property taxes on homeowners here in

22 We are -- I will tell you the 9/11  
23 Memorial on Long Beach Road is truly a  
24 beautiful site. We -- it's a beautiful
