## ORDINANCE NO. 34-G

## MUNICIPAL PARKING FIELD

### Section 1

The following property shall be hereafter known as the Municipal Parking Field:

Being at the easterly side of Nassau Lane, beginning at the corner from, by the near section of the northerly side of Long Beach Road and the easterly side of Nassau Lane, thence northerly along the easterly side of Nassau Lane 300 ft. plus or minus, then westerly along the northerly side of Warwick Road 67.93 ft. plus or minus; then northerly along the easterly side of Nassau Lane 220 ft. plus or minus; then easterly along the dividing line between lots 12 and 13 in Block 13 a distance of 130.56 ft. plus or minus; then southerly along the property of the Long Island Railroad 585 ft. plus or minus, to the northerly side of Long Beach Road; then westerly along the northerly side of Long Beach Road 66.06 ft. plus or minus, to the point of beginning:

(a) The following property shall be hereafter known as Municipal Parking Field No. 2: That property known as lots 13 to 17 inclusive in Block 13, Section 43, on the "Nassau County Land and Tax Map". (Addition enacted April 14, 1960)

## Section 2

No person shall park or permit to stand any vehicle in any part of the aforesaid parking field for more than two continuous hours between 7 A.M. and 7 P.M., in any one day, except upon payment of the fee hereinafter prescribed, and the receipt and display of the license described.

#### Section 2.1

No person shall park any vehicle across any line or marking designating a parking space or in any way that the same shall not be wholly within a parking space designated by said lines or markings.

#### Section 2.2

No persons shall park any commercial vehicle in the aforesaid parking field.

# Section 2.3

The following spaces are hereby reserved for Police Department vehicles, in which no persons other than Police Officers shall park a vehicle; on the south side of the first aforementioned parking field (4 spaces, where posted.)

# Section 2.4

The following spaces are hereby reserved for taxi-cabs licensed by the Village of Island Park. On the south side of the first aforementioned parking field (2 spaces where posted).

# Section 3

The fee for parking shall be as follows:

- (a) For residents of the Village of Island Park \$5.00 for each calendar year. (Amended April 25, 1979)
- (b) For employees of any person conducting a business within the Village of Island Park \$1.00 for each calendar year.
- (c) Residents of Island Park School District outside the Incorporated Village of Island Park \$45.00.
- (d) Residents outside the Island Park School District \$75.00 (Amended October 18, 1979)
- (e) A fee of \$1.00 shall be charged to replace a tag, sticker or plate lost or destroyed, or to transfer a license to a vehicle other than the one originally applied for. (Amended November 20, 1958)

## Section 4

A descriptive tag, sticker, or plate shall be issued by the Village Clerk, upon payment of said fee, which shall be conspicuously displayed on or within the said vehicle for which the license is issued. Said license not to be transferrable.

# Section 5

The Board of Trustees of the said Village of Island Park may hereafter, at such time or times as the said Board deems advisable, by resolution, designate other parking fields in the Village of Island Park, to be used upon the terms and conditions as set forth in this Ordinance.

## Section 6

Any violation of the provisions of this Ordinance shall be deemed to be disorderly conduct, punishable, upon conviction, by a fine of not less than three (3) dollars nor more than twenty-five (\$25) dollars, for each offense. (Amended May 19, 1960)

## Section 7

The present Ordinance No. 34-F is hereby repealed.
