

ORDINANCE NO. 37

HAWKING AND PEDDLING

Section 1 Definitions

Any person, firm, corporation or association hawking, peddling, soliciting orders by going from house to house or carrying goods, wares, merchandise or other commodities in the streets, highways or public places of and in the Village of Island Park, shall be deemed a peddler.

Section 2 Exceptions

Section 2 thereof is hereby repealed.

Section 3 License

No peddler shall ply his trade in the Village of Island Park without first having obtained a license from the Village Clerk and paying an annual fee or fees as hereinafter set forth.

Section 4 License Fees, Terms

The annual license fee payable by peddlers shall be for each peddler:

- (a) Persons who hawk or peddle any perishable foods or edibles except milk — (\$75.00)
- (b) Persons who hawk or peddle all other articles of merchandise except perishable foods, edibles and milk — (\$50.00)
- (c) Persons who solicit orders for goods, wares and merchandise to be delivered in the future or services to be performed in the future (\$50.00)
- (d) Persons who solicit order for services to be performed upon the premises at the time of such solicitation — (\$50.00)

Said license fee shall be due and payable on the first day of May in each and every year and shall expire on the 30th day of April in each and every year.

Section 5 Designation of Vehicles

Upon the payment of fee as hereinbefore provided, the Village Clerk may issue a license to the owner of the vehicle, together with a plate to be affixed to a conspicuous and indispensable part of such vehicle on which shall be clearly set forth the official number of such vehicle, together with the words "Licensed Peddler, Village of Island Park". The design of the plate shall be changed at the beginning of each license year. A separate fee shall be charged for each vehicle used by any one person, firm or corporation.

Any peddler duly licensed to use a horse and wagon or motor vehicle may employ one person, and no more, to assist in selling and delivering the wares but such persons shall act only while accompanying licensed peddlers.

Section 6

No peddler or solicitor shall have any exclusive right to any location in the public streets, nor shall any peddler or solicitor be permitted to sell wares within 200 feet of a school between the hours of 8 A.M. and 4:30 P.M. on a school day, nor shall be permitted to stand in one place for more than 15 minutes, nor shall he be permitted to stop within 200 feet of a previous stop, nor shall he be permitted to operate in any congested area where his operation might impede or inconvenience the public, nor shall he be permitted to operate within 200 feet of an established business selling the same or related goods. For the purpose of this ordinance, the judgment of any police officer, exercised in good faith, shall be deemed conclusive as to whether the area is congested or the public impeded or inconvenienced (Amended November 16, 1961).

Section 7

The hours during which any hawking, peddling or canvassing shall be permitted in this Village for persons duly licensed as provided for in this ordinance shall be from Monday to Friday inclusive between the hours of 8 A.M. and 1 P.M. and at all other times except as herein set forth, shall be prohibited to hawk, peddle or canvas in this Village (Addition enacted March 19, 1953).

Note: ordinance #37 was repealed and the above Ordinance #37 duly adopted on July 26, 1938.

Section 2 thereof is hereby repealed.
