#### **SECTION 1. LEGISLATIVE INTENT**

## **SECTION 3. MASONE BEACH SNACK SHACK**

The Masone Beach Office is authorized to rent Beach Umbrellas and Chairs, and sell Village Logo Merchandise and Snacks according to the fee schedule set forth in Section 4 herein.
